Director's Objective

To use one's personal skills, knowledge and influence to govern an organisation in order to improve shareholder/stakeholder value, meet the aims of the entity, and in many cases get personal monetary gain from such duties.

The magnitude of the problem

- Some 400,000 Directors on Companies Register- (6000+ members of IoD)
- 2012 102 fatalities
- 2012 378 serious workplace injuries
- Agriculture, fishing, forestry, mining, construction and manufacturing are major culprits

£250,000+ fines after HGV driver paralysed

Two haulage companies have been sentenced for safety failings after an HGV driver was left paralysed from the chest down following an incident at a transport yard in Sandy, Bedfordshire.

The 51-year-old man, from St Ives, Cambridgeshire, was crushed as he was closing the rear doors of his HGV when another lorry reversed into the area he was working in at the yard on Tyne Road, which was being rented by his employers H & M Distribution Ltd.

The worker, who does not wish to be named, suffered life-changing injuries and will be unable to work again. As well as his paralysis, he suffered a brain injury which has affected his sight and has lost most of the use of his arms.

Changes in legislation

- Health and Safety at Work Act 2015
 - In revision stage
 - Likely effective date between 1st April to 1st July 2015
 - New regulations for many industry sectors

Changes in legislation- the test

• As far as reasonably practicable

 What is or was reasonably able to be done to ensure health and safety taking into account and weighing up all reasonable matters.

So what does it mean to Directors?

- Officers have a due diligence duty
- The duty is individual not corporate!
 n.b. the "Easy Rider" prosecution
- Includes:
 - Knowledge of up to date HS matters
 - Understanding the nature of the operations, its hazards and risks
 - Ensure that PCBU has available the resources
 - and processes to eliminate or mitigate risk

• Includes:

- Ensuring that PCBU has processes for receiving and considering information regarding, incidents, hazards and risks
- Ensuring PCBU has, and implements, processes for complying with the Act
- Verify the provision and use of resources and processes referred to above



How can Director risk be mitigated?

- Education
 - e.g. IoD courses
- Evaluation
 - Having HS on Board agenda every time
 - Get an external assessment e.g. "BoardSafe"
- Engagement
 - Getting out and seeing that things are actually happening in the workplace as you asked for then to be done by Management
